Rules and Safety Regulations

SVE Hours of Operation:

8:00 am – 8:00 pm M,W,Th, and F
8:00 am – 5:00 pm Tuesday
8:00 am – 6:00 pm Saturday
8:00 am – 12:00 pm Sunday

Notice of Required Release and Waiver:

- 1) *Anyone* riding any horse MUST have a Rider's Release on file at SVE.
- 2) *Anyone* caring for any horse or *visiting* SVE's premises MUST have a Visitor's Release or Rider's Release on file at SVE.
- 3) Minors must have a release signed by both parents (if applicable) or their guardian.

Barn Services:

- 1) Your Boarding Agreement includes:
Basic Board, Feeding Daily, and Cleaning Daily
- 2) All horses boarding at SVE must participate in the mandatory worming and vaccination schedule. SVE will arrange worming and vaccination at your expense.
- 3) Lessons are available ONLY with a SVE Trainer.
- 4) If you have Special Needs or need to make temporary or long term changes you MUST speak with Michele Vaughn ONLY. Staff is prohibited from making any special arrangements.
- 5) You are required to pick up after yourself and must discard your garbage.

SVE Safety Rules:

- 1) No use of cell phones while attending to or riding a horse.
- 2) No lunging in covered arena. No more than one horse may be lunged in round pen or arena designated for lunging.
- 3) No turnout of any horses in any arenas. Turnout only in turnout areas. Clean-up grooming area's before riding and after. Keep clean and free of hair and manure. Tack should be kept clean. Pads should be kept clean.
- 4) We love dogs, but for the safety of all, we MUST enforce NO DOGS ALLOWED ON PREMISES.
- 5) Cars must be parked in designated parking areas only. Do not block driveways to any building. Parking your car or trailer is AT YOUR OWN RISK. SVE is not responsible for damage to the vehicles or its contents. Trailer parking is in designated areas only.
- 6) Be aware of safety at all times!
- 7) Ring Etiquette: Pass left shoulder to left shoulder. Do not walk or stop on the track if others are riding. Be courteous and careful, especially when lessons are being given. When you want to enter the arena, call out, "May I come in?" to alert riders. Riders will reply, "Come in" when the path is clear to enter.
- 8) Proper Riding Attire: For your safety this must be enforced at all times:



Bridle and Saddle



Boots with heels only



AHSA approved headgear with chin strap
required while jumping



Safety helmet required at all times



No cell phones

Barn Management:

- 1) We REQUIRE that all horses in our care be exercised a MINIMUM of 30 minutes every other day. If you do not ride, lunge, or walk your horse it will be done for you. NO NOTICE WILL BE GIVEN, refer to fee schedule.
- 2) Pasture turnout must be administered by SVE staff only.
- 3) NEVER help yourself to SVE's or anyone else's tack, feed or supplies.
- 4) Make sure your NAME is on everything. Please keep us advised of any name, phone number, and address changes.
- 5) Please conserve energy by turning off unnecessary lights in the barn and tack rooms when no one is present.
- 6) Please Conserve Water!
- 7) The phone in the tack room is STRICTLY for SVE use only, except for a medical emergency.

8) **SMOKING IS PROHIBITED** at all times anywhere on SVE property.

Barn Upkeep

- 1) Clean up manure immediately anywhere on the property, aisle ways, driveways, or parking areas. Aisle ways, tack rooms and wash racks must be kept neat and clean.
- 2) Please clean up after yourself! No littering, please!
- 3) Please clean up after yourself in the kitchen area. The refrigerator will be cleaned out the first and fifteenth of each month, any items left or unmarked will be thrown out.
- 4) Each stall is provided a saddle rack, bridle rack, and locker for your personal belongings. No tack trunks or other storage compartments are allowed on the premises.

These rules are set in place for the safety of SVE clients, and visitors. We appreciate your cooperation and hope you enjoy your time here at SVE! All rules and regulations will be enforced at all times.
